IRAC Work Group Updates and Discussion

Risk-based inspection workshop held December, 2009

Wendy Hall gave an overview of the risk-based inspection workshop held in December, 2009. Wendy will draft a proposed project description for developing a new working group on risk based inspection, with help from Janell Kause. This will be reviewed at the next meeting for approval.

Nanotechnology and Risk Assessment Work Group

An outline for a white paper was sent out for comments prior to January 2010. Comments were received and Villie Flari will prepare a first draft based on the outline. This should be completed by mid April. Once complete, the draft will be sent to IRAC members to provide comments/ suggestions for changes. Villie noted that there will be a workshop in the UK on nanotechnology enabled food products, May 27-28, 2010. The workshop will bring together regulators, academics and industry to talk about a risk assessment model for nanotech foods, including how to regulate such foods.

Susceptible populations Work Group

The work group held a workshop on identifying and characterizing susceptible populations in January, 2010. Most of the meeting presentations and the reports from the two working groups (on chemical and microbial hazards) have been posted at the IRAC website on www.foodrisk.org. The group discussed continuing work on this activity. New leadership will be needed for the group due to Steve Gendel changing work responsibilities. An editor is needed to take the draft papers and prepare a document for publication in the journal Risk Analysis.
