Public Disclosure of Tests for Salmonella: The Effects on Food Safety Performance in Chicken Slaughter Establishments.

USDA Economic Research Service (ERS)

This report examines how disclosing the identities of chicken slaughter establishments with poor or mediocre performance on Food Safety and Inspection Service (FSIS) tests for *Salmonella* spp. affects subsequent test outcomes. Empirical results show that public disclosure of the identities of such establishments is strongly correlated with a substantial drop in *Salmonella* spp. levels over 2006-14. The reduction in *Salmonella* spp. levels demonstrated that the permissible amount of *Salmonella* spp. on carcasses of young chickens could be lower and enabled FSIS to reduce tolerances for *Salmonella* spp. on the carcasses by more than 50 percent.
