## **Discussions of New Activities**

<u>New workgroups</u> Workgroup proposals are posted on the IRAC website. Workgroup leads provided brief updates on progress and plans.

- A. *Risk Communication: Improving Internal Processes and Outcomes* Rachel Johnson (USDA/FSIS). Currently discussing description of risk communication processes in different agencies and identifying barriers/stumbling blocks.
- B. *Evaluation of Dietary Assessment Tools* –Alex Domesle (USDA/FSIS) reported on scoping the project, identifying data sources, computational models and software, and information on how each agency uses dietary assessments.
- C. Food Access, Nutrition, and Risk of Foodborne Illness .
