



## **Technical Representatives and Policy Council Quarterly Meeting**

March 31, 2016; *Meeting Minutes*

### **Welcome and Introductions**

The Interagency Risk Assessment Consortium (IRAC) held its March 2016 quarterly meeting of the Technical Committee and Policy Council on March 31, 2016. The meeting was hosted by USDA/OPMP via webinar. Technical and policy representatives and guests from various agencies (Tables 1 and 2) participated by phone.

### **Main Presentation**

Randy Duverna, USDA FSIS, presented on "Modernizing the Mechanism for Chemical Identification and Prioritization in Animal Products Monitored by the U.S. National Residue Program." In addition, he will be soliciting feedback from IRAC participants on FSIS's proposed approach for prioritizing chemical hazards for inclusion in the FSIS sampling program.

### **"5 minute" Agency Updates**

Representatives in attendance gave a brief overview of food safety risk analysis projects and issues in their agencies that may be of interest to other agencies.

### **Work Group Updates**

Judi Spungen, FDA CFSAN, provided an update on the IRAC Dietary Exposure Assessment Working Group.

- Existing outline has been expanded, and a timeline has been developed.
- We've assigned sections of the outline to different people and hopefully each agency will have a first draft by the end of April and a more polished draft by the end of May.

March: Jorge Muniz Ortiz, Lindsay Ward, and Wayne Schlosser presented about exposure assessment at FSIS

Abe Tobia is tentatively presenting talk on exposure assessment at CVM at our April meeting.

Janell Kause, USDA FSIS, provided an update on the IRAC Workgroup on “Food Access, Nutrition, and Risk of Foodborne Illness.” The workgroup is hosting a one-day, invitation-only workshop on the interrelationship between food access, nutrition and food safety on May 20<sup>th</sup> at USDA (South Cafeteria) from 9:30 am-3:30 pm. Purpose: The workshop will provide an opportunity for Interagency Risk Assessment Consortium (IRAC) member agencies to explore the broad interrelationships between food access, nutrition, and the risk of foodborne illness and identify opportunities for further interagency collaboration and coordination among food nutrition and food safety professionals within the federal government. This workshop serves as foundation for further interagency discussions among federal agencies on the science and interrelationships between food nutrition and food safety.

Subject areas to be addressed:

- Relationship Between Socioeconomic Status, Nutrition and Susceptibility to Foodborne Illness: This includes national and international studies on lower socioeconomic status and the link to nutrition and corresponding risk of infection from foodborne pathogens.
- Emerging Science: Microbiome – a Link Between Nutrition and Food Safety: This includes the emerging science of the microbiomes and the role of nutrition in susceptibility to foodborne illness.
- Use of Food Nutrition and Food Safety Information – Opportunities in Community Outreach: Current work of USDA and DHHS program to better characterize and address complex challenges of underserved community health through improved nutrition and food safety. This covers some of the current data and information needs to better target federal public health resources to improve community health.

Format: Presentations and roundtable discussion
